Minutes of 150<sup>th</sup> SWC: Minutes of 150<sup>th</sup> SWC held on 24/2/2019 at IMA House Nagaon were read out by HSS Dr H Baishya. The minutes were confirmed by the house. Dr H K Borah of Tezpur branch enquired about non receipt of IMA Calling despite collection of Rs 500 each member in last SWC. Dr A K Kalita Past HSS responded by saying that he could not publish the IMA calling due to some personal problems and also due to lack of enough materials for it. He could manage to take few digital copies of IMA Calling to be released in Medimeet 2019 in Nagaon. He said hard copies can be made ready soon.

President Dr S Borah opined that printing may be put on halt as of now as it will incur more cost, instead upload a PDF copy in our website.

Report of Honorary State Secretary: Dr H Baishya, HSS presented the secretarial report after welcoming all members. He expresses grave concern over the issue of Violence on doctors with special mention of Dr P C Thakur case. The house expresses its satisfaction on the handling and management on Dr P C Thakur case and thanked everyone for its solidarity and support in protest of such heinous act. President Dr S Borah offered thanks to all branches for standing united against violence against Doctors.

Dr H K Borah enquired about the update on the meeting on bridge course held in New Delhi. Dr H Baishya and Dr Atul Kalita responded and said detailed discussion was done on bridge course and PCPNDT. IMA will continue its fight against PCPNDT and bridge course. The house had a detail discussion on the subject. The house approves 3 tier AC train fare for MSN volunteers to attend IMA MSN National Council Meeting in Delhi.

After discussion house confirms and approves the secretarial report.

Report of HSFS: It is worth mentioning that the State council in Nagaon medimeet requested then HSFS to complete the financial record and transactions upto 31<sup>st</sup> March 2019 and present them in next SWC. Accordingly then HSFS Dr H Baishya read out the financial report. The current HSFC Dr Rajumani Sarma read out the statement for the month of April 2019 only. After a detailed discussion the house expresses dissatisfaction over expiry of Bank drafts deposited for election purpose and directs the office bearers to reissue the drafts from respective banks and submit it.

Dr Satyajit Borah raised a question about the gross financial indiscipline during last 2 years where then HSS kept a huge amount of cash in hand. He also questions the high fuel expenses incurred by then HSS. The house directs for the Dr. Br. Dr. Barthura HSS. Dr. Baithurani Sarma to book into the moderated hills and

The house also discussed the high expenditure incurred during visit of National leaders during last year. The house strictly disallows any such expenditure if any leader comes to visit other states via Assam.

The House also affirms that entitlements of IMA office bearers like fuel and travel expenses for official visits may be paid by IMA ASB.

IMA HQ requests all state branches to contribute for FANI cyclone victim of Orissa, and SWC approves maximum amount of Rs 25000.00 for that.

IMA AMS: Dr Rajib Gayan addressed the house and he informed the house regarding his lack of understanding on IMA AMS function. Dr Tapan Deka raised an issue of training of newly elected office bearers about different aspects of IMA and how IMA functions.

Dr Apurva Bhattacharya asks to update the IMA AMS member list and appeals to increase the membership.
